<u>ORDER</u>

Government of Kerala has initiated several measures to integrate the Kerala Diaspora outside Kerala with the State. One such initiative ha been the successful conduct of Loka Kerala Sabha from 12 – 13January, 2018. The event brought together persons of eminence in various walks of life under one platform to discuss issues concerning the Kerala's diaspora. Several worthy suggestions emerged in the social, economic, cultural and science & Technology sectors. Government therefore intends to take forward those suggestions to create a workable policy solutions.

In this regard, Government are pleased to constitute seven sector specific standing committees for them to deliberate issues in detail. The constitution of the committee is as under. These committees are expected to meet as frequently as possible, to prepare their report in three months. The Chairmen of the committee could invite experts in any particular field, if there is need for assisting the committee. Each committee will prepare a detailed report in the sector they are involved with and submit the same to the Government. These reports will be examined and acted upon by the Government, as was decided in the Loka Kerala Sabha 2018. The meetings can be held at places convenient to the members.
